In the past few years, *Lippincott Procedures* has expanded into several specialty areas including physical therapy, respiratory therapy and long-term care. Once complete, this new set of ambulatory procedures will create a new category that follows the same familiar structure and format that nurses are accustomed to using already. The new procedures are expected to be available starting in January 2016.
